MEMORANDUM OF UNDERSTANDING ON ACADEMIC COOPERATION

Between

ROYAL ROADS UNIVERSITY Victoria, British Columbia, Canada

And

UNIVERSIDAD DE LOS LAGOS Osorno, Chile

Located in Victoria, British Columbia, Royal Roads University is a special purpose public university that offers a unique model for post-secondary education for the 21st century. Royal Roads University delivers blended and face-to-face, quality applied and professional programs designed to advance students and professionals in a world increasingly driven by knowledge and innovation. Royal Roads University offers a wide range of both graduate and undergraduate degrees, as well as executive education in Business, Management, and Social and Applied Sciences.

Located in Oscorno, Chile, the University of Los Lagos is a regional public university whose mission is the training of professionals and technicians with sound knowledge of basic and applied scientific research in strategic and competitive areas of expertise. The University of Los Lagos is an institution valued at the regional and national level for its quality of technical and vocational training and scientific and technological development in strategic areas.

This MEMORANDUM OF UNDERSTANDING (MOU) is designed to foster a friendly relationship through mutual cooperation in teaching and research between Royal Roads University (RRU) and Universidad de Los Lagos (ULAGOS) hereinafter jointly referred as "The Parties". No financial obligations are assumed under this agreement.

The Parties have reached agreement on the following areas of cooperation, subject to mutual constant and the availability of sufficient funding:

Exchange of faculty

- Joint research activities
- Participation in seminars and academic meetings
- Exchange of academic materials and other information
- Special short-term academic programs
- Student exchange for research and study

The terms of such mutual assistance and funding for any specific program and activity shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of a particular program.

Each institution will designate an individual to coordinate this program and all endeavors that may derive from it. For this purpose, UNIVERSIDAD DE LOS LAGOS designates Julio Enrique Crespo Soto, Director of International Relations and ROYAL ROADS UNIVERSITY designates Pedro Márquez, Vice-President, Global, Marketing and Business Development.

No amendment, consent, or waiver of terms of this MOU shall bind either party unless in writing and signed by all parties. Any such amendment, consent, or waiver shall be effective only in the specific instance and for the specified purpose given. The parties to this MOU, by the signatures below of their authorized representatives, acknowledge having read and understood this MOU and agree to be bound by its terms and conditions.

This MOU shall commence on the date of latest signature and be in effect for five (5) years, at which time it shall be reviewed for possible extension. Either party may terminate this MOU by written notification signed by the appropriate official of the institution initiating the notice. However, such notification must be received by the other party at least six (6) months prior to the effective date of termination.

This agreement will become the basis for more specific areas of cooperation and collaboration which will be formally agreed to, and become addendums to this agreement.
